

We shall see if this leaves her less groggy in the morning, but still able to get a good sleep. All the other meds remain the same.

Amber is still anxious about going to Savannah for the movie. The plan is to fill in all the details she can before going. This is an imperfect plan for some of the logistics are not in her control, which is upsetting. That level of upset she will learn to deal with.

We discussed her frustration with her career. Also discussed some of the difficulties with bringing along an assistant to the shoot in October. My impression is that her relationship with J is much smoother. He continues to be supportive to her doing the movie. We discussed trying to lay in plans for visits while she is on location.

Amber reports using some of the tools I've given her actively and with good results. She seems pleased with herself, more confident.

She will be back in Los Angeles next Tuesday for a few days so will get some face time.



I have respected your advice to leave him alone. Completely. I haven't even texted him. And have trusted your care and direction, despite how confusing and scary it is at times.

Last night when we spoke I was upset primarily because I had expectations to get some clarity on what was going on - what the plan was (set boundaries...

abandon them?... etc) - what your perspective was (complete relapse, move on...?) but felt I was being shut down and out. I continue to feel alienated and confused. On top of having the man I love fall into relapse.

So of course, i was upset but No excuse for allowing it to somehow upset you too.

Amber sent me the following text message from JD. Clearly, he is reaching out (sent to Amber's sister who he knew would forward the message to Amber).

Hey, sweet Sis...

Thank you, honey... How is my little girl???

Fuck...? I miss her so much !!! Hal

Don't know why, but... somehow... I make her miserable and then the shit-storm commences... And, as you well know... She goes for the jugular... And doesn't stop until she feels that she successfully provoked me to feel true rage and profound sadness... That is no way for anyone to live...

I have only wanted her to work on her self, not just for us, but, of course, for her!!! I can't tell you how fucked and sad I felt when she flat out lied to me ... TO MY FUCKING FACE!!! And also, when I was not in Georgia...!!!

What would she do if I did that??? WE ARE 3 GODDAM YEARS DOWN OUR CHOSEN ROAD!!!

How many times did she, not just avoid the truth to protect me from unpleasantries that she would rather I had no knowledge of??? She was my best friend... And then it's been battle after battle... When lies and untruths become standard fare!!
