I hope you are doing well. I keep hearing about all the money you are raising for the centennial campaign and can only imagine how worn out you must be. I hope you are finding time for yourself.

Coincidentally, I am writing with good news regarding your fundraising efforts. Late last night we received a couriered package at the office here in LA with a check and commitment letter regarding the Amber Heard pledge. Thank you for working your magic!

I've attached the full letter, but the heart of the message that accompanied the \$100k check read that this gift made "in the name of Amber Heard ... represents the first of multiple scheduled installments to honor the full amount of Ms. Heard's \$3,500,000 pledged gift." The actual check is from Mr. Depp (c/o his CPA) and handwritten on the check, it says "Donation being made in the name of Amber Heard."

My staff let me know that you have been the point person, so I wanted to check in with you directly with this update.
