IT APPEARING that Adam R. Waldman is an attorney in good standing with California; and

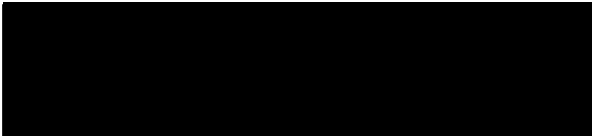
IT APPEARING that there is no objection to such admission (as evidenced by the signatures of counsel below); and

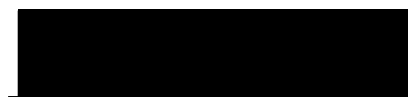
Virginia and permitted to conduct, participate in, and defend all depositions related to the pendency of this action without local counsel being present.

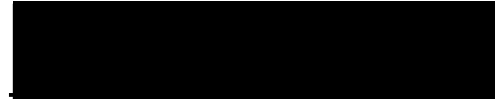
