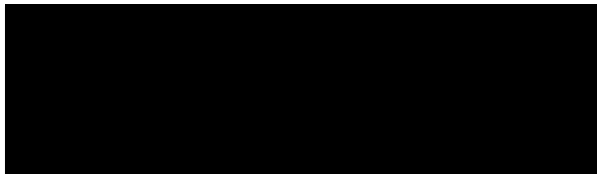

2. Kathleen T. Zellner, Esq. is admitted as *pro hac vice* counsel in the above-captioned matter.

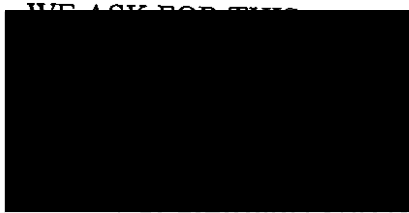
