- **organised in a timely manner**

- I think video and audio recordings are particularly important because they capture the atmosphere of the moment and are not tainted by later (not) recollection
- this started as an attempt to make sense of the recordings mentioned in legal proceedings, then grew into a collection of various other interviews and videos that I think shed light on JD's and AH's characters, then I added interviews of other people involved

- 320+ audio and video recordings were in JD's possession on 7th August 2020, of which 50-51 include AH, they date 4 – 8 years ago (some of these JD is withholding on Fifth Amendment grounds, according to AH, because they were made without AH's consent); these include 15h30 of audio recordings mentioned on 10th March 2020; hopefully they also include other instances of AH secretly recording JD that we have yet to see
- 87 cctv footage clips were collected by JD's divorce lawyers in May 2016 (72h of footage)
- 89 newly obtained cctc footage clips came into JD's possession before 1st March 2019, they are from the Eastern, as stated on 26th November 2019
- 13 more videos were received by NGN on 17th June 2020
