

AH: -we are done like negotiating or talking. It's important to go through okay, done, done, that's when the [] process starts. And so I text you this, and I guess you don't remember it, but I text you that at you know-um-um- at the very beginning and I said by the way, by a miracle it didn't get noted so. We said we can do this privately and it will be quiet and-and you know- and I said unless you file, and you don't have to file. And I was like trying- I was trying to explain to you and I remember you not understanding this-

JD: My filing did nothing and all- it's-it's required.

AH: No, it's not.

JD: It's required to acknowledge you have been-

AH: No, it's not.

JD: -filed against and when you file it- you file it- uh-uh- as well.

AH: No, you do not. You-you make-you can make an acknowledgement of some kind, you don't have to file back. When you file back in court-

JD: Um-um- Amber.

AH: I'm not lyin- I'm just really trying to- you know what? You're trying to- I feel like you are trying to defend yourself and um-um- you don't have to defend your team. We know there is a fuck up. But-you-you- hear me? Please stop trying to defend yourself I'm not trying to fight with you. I'm just trying to tell you the truth. This is truth. I don't know why you're so- why you're so angry about hearing it or why-why you are so defensive-

JD: Baby, I'm not angry.

AH: -I just wanted you to have all the information.

JD: I'm not angry, I want this to go away. I'm trying to talk you into making this go away.

AH: Then-then you- then you need to know the real truth behind this and this is important. This was completely private and it was out of the radar and you didn't have to file back. I warned you that day, you don't have to file back- if you- if you file back it opens it up to being discovered. And I was thinking naively that would be just be just discovered by the way like TMZ typically discovers these things. I didn't know that it would be hand delivered to them within five- like five [unintelligible]. I did not know it would be given to them. I did not know- I couldn't have known at that time how-how much Laura was going to use TMZ- um- to her favour. I did not know that, so I just thought naively that TMZ could likely discovered it if it was filed on your part. I warned you, I said this to you thinking that you were going to be participating and I said 'hey, just so you know, you don't have to file. I'm not gonna blast you. I don't wanna stop talking, you know- whatever, whatever- and you don't have to file. If you file, it just opens us up to being discovered.' Because by- for some reason the way we file-

JD: What would-

AH: -my lawyer, when she files, she gave explicit instructions to file within a stack of bunch of other paperwork at the end of the day, so that it would be-it would be more likely not be discovered. And I'm told that would be the most effective method to be- at having a shot of it not being picked up for a day or two. I thought that hey, maybe it will by a few hours, you know? And I worked really hard and so did my team and it- it didn't get picked up by some miracle. So, like, for literally three days it

did not get known about. Eight minutes or five minutes after your team filed for you, which is a move they didn't have to make- then it was picked up by TMZ. It was given to TMZ within five minutes of it being filed and Laura went and did it at very opening hours on a business day on top of a stack of paperwork. That is the opposite of keeping it private. And I just want you to know the whole truth. Fuck it, if I were you I would want to know all the information.

JD: I do, I do, I'd like you to know all the information too. But did-did- I mean do you have proof of that?

AH: ...Yeah.

JD: Good, good, excellent. What- I didn't- I mean I didn't know anything about her filing to the fucking TMZ or any shit like that. She knows what I wanted. I don't-

AH: So, uh-maybe she's trying to do what was best for you without knowing maybe- you know- I don't – I-I- I don't know but she-she-it- I'll put it to you this way um- without being able to show you what- people that-without being able to show you and expose- my source one of which, one of them actually, in this regard. Without doing that I can just tell you the basic facts, like it was private for days after I filed. You did not have to file. That's not a move that one- the other party has to make.

JD: Okay-

AH: It's just not.

JD: Okay.

AH: And you did. Or your team did.

JD: Okay-

AH: And then, within five minutes there was a file being given to TMZ. You just do the math yourself without being [unintelligible] nearby, it's very clear.

JD: Okay. I-

AH: And I don't know if you knew that.

JD: No, I didn't know that and-and if that is the case I'll-I'll acknowledge it. You know [clears throat] and if you say you have proof I'll acknowledge it. Look, it doesn't shock me, that- that -any [bleeped out] that someone would do something like that it doesn't you know-um-

AH: Yeah.

JD: It doesn't shock me. But I'm telling you now, if I file, if they file the fucking papers tomorrow, which means the shit I've got to file before we go to court on Friday, if they file those papers- first of all, it's very bad for both of us. Okay?

AH: Well, your people are not going to file anything that's bad for you, trust me.

JD: No, no what you're saying, you've got to do something to protect yourself which means throwing me under the bus for the, some video about me beating you?

AH: Not me. I have to respond. I mean I'll have to go and pursue, no I'll pursue the whole course of action, because here's what you don't understand. If, if we do this, and basically will know. I called my lawyers and I said why aren't we negotiating now, what's going on, where are we, and they're like everything's under court.

JD: No, they won't settle. Your agents won't settle. Your lawyers won't settle baby. I'm telling you.

AH: No. We want to mediate. We even have a mediator, found a mediator and everything. But that was all worked out. But the thing that Laura wouldn't agree to, she did not want to agree to a mutual gag order. And that's the problem, she doesn't want the gag order, why Johnny? Why? Why wouldn't she? Why wouldn't she want both parties not to talk about this in the press? By the way, I'm just talking about the press, not even talking about the court.

JD: Okay-

AH: Why?

JD: I'll tell you what. Amber, let me get on that right now. I'll fucking get on it right now. And-and I'll get a message back to you somehow. Just- you know- uh- I'll get on it right now.

AH: I just want you to know. I'm not doing anything and have not been doing any move. Look it up, the timeline. Nothing was on the offense. Everything has been a defensive move because I'm being called a liar and a gold-digger. And I am not lying about any of this shit, and I am not after a dime of your money. And, you know what? I was told by Laura after the first mee- the thing, the reason that I fucking stupid [unintelligible] court was because I knew that was my only option because no divorce attorney would ever say not and loose all rights to everything. Laura Wasser had proposed that I need to – not proposed, I'm sorry said that I would have to leave, I'd be kicked out, I'd be evicted. So Rock and Josh and everybody- evicted within twenty-one days.

JD: No, but I told you-

AH: What?

JD: -last time we spoke I told you. That you were fine, you stay there two, three, fucking four months, whatever, just fucking figure it out- we'll figure it out. You stay there you'll be comf-

AH: I thought that too.

JD: When you're home.

AH: Twenty one days.

JD: Be in your home!

AH: No, I thought that too. They told me twenty one days. That is part of why I accused you of doing that. This-this the thing- that's why I could [unintelligible] I didn't wait for the right to stay in our home. That's how fucked up this- I'm having to do everything, every step I've had to make, my hand was forced in it! By [bleeped] oppressive moves made on your team's behalf. And now I've got [bleeped] myself every second away. And it only hurts you! I don't wanna hurt you! I love you!

JD: It's hurting **you**. It's hurting **you**. And it's hurting me. But the worst fucking thing is-

AH: But, it becomes court-

JD: Do you want to go to court Amber? Seriously? Do you want to go to court with this? I'm offering you an opportunity for us to make this finish in peace. Peaceful, man. We walk away. You go do what you gotta do, I go do what I gotta do. I, I, I've been through the f**king hurt. You've been through the f**king hurt. I love you more than anything in life. But, I do not want to go into a f**king

court with you. I do not want to f**king tarnish your name. I do not want to f**king tarnish. I don't want nothing. I want this to be done peacefully, between us. And if you don't like the way that mediation is going, take me back to court, kid. Cause I can't. This is the last f**king chance Amber. This is it. Once they file those papers we don't turn around man. I know you hate me, and I know you whatever, I'm telling you now, there's no call, it doesn't need to happen like this. Please, for f**ks sake trust me man. I was not gonna help you in this. Nobody's gonna help you in this. I'm trying to help you in this. I love you. Regardless whether we are together or not. I will love you and I have loved you, with everything in the fucking world. Whether your love was real or not, I love you. And I- I want this- [phone rings] Hey.

AH: Hey. Can you hear me?

JD: Course everything that I said was not heard, right? Fuck me.

AH: I don't know. I don't know where-

JD: I know. What I was trying to say was this, continuing through court is going to end up nothing but bad for you, and for me. It's just going to be bad. In any case, no matter whether we ruin each other or not, it's going to be f**king heartbreaking, it's terrible. Let's write a mutual letter that says look, in lieu of what's transpiring out there in the world with all this f**king crazy s**t, we have decided to take this private. We're not going to go to court, right now, over this. We are going to try to work something out, together. And then at least, at the very f**king least. I know you want to respond, and I know you want to defend yourself. Listen to me. Defending yourself by throwing someone under the bus is not going to look good.

AH: I'm not. It's not about that. It would not be about me throwing you under the bus. You know what it would be? It would be released through documented people, coming on the record, and, having the protection to do so, that haven't had yet. It would be eyewitness statements. It would be evidence. Tons of it. And it would be through years. And it would be unbelievable. Unbelievable, um, to imagine that either I'm (a) in a secret fight club, or (b) I've had um...

JD: A secret what?

AH: A secret fight club. Or that I have been plotting to do this for three years, and, while taking pictures of it, and documenting it, just saving it up for the right time when I'm not asking for any money and have nothing financial to gain from it. But no one is going to believe that. No one is going to believe that one of the two alternatives, that I'm in a fight club or I've been getting, going through hair and makeup or going through makeup through all these years where I have corroborating text messages between people that match those dates of those time stamped validated photos of either corroboration between people hearing us or corroboration of next day, you know, Whitney sending text messages to Kevin, him responding or you know the kind of stuff between me and people in your life. It is insanely cross-corroborated than it is planned. I'm gonna put make up on myself and take pictures throughout years and sit on it for years. That- that- while having this imaginary life run through you. You understand that I- the pictures that I have match with like text messages with my mom back and forth about it, you know, and text messages between say Raquel and my mom or Raquel or my dad. Or you know, between my two friends. There is a text message where I tell Jodi the night before I have that James Cordon night show thing. Where I say [fake crying] 'Hey Jodi, I had an accident- um- I think I might have- it's possible that I may have a busted nose and two black eyes tomorrow because I - I don't- all that warn that we need to cancel. But [unintelligible] I don't know how. I don't know how my face will be tomorrow, you know [laughs] and things like that. It doesn't matter. There is nothing- nothing and all of that won't be me throwing you under the bus, that will

be evidence, in the case. Which I will have to, it will be criminal as well, because I cannot go on Friday and file without filing a police statement first. And the only reason I haven't filed a police statement, which has been used against me by the way, every day, and the only reason I won't do it, haven't done it, is because I don't want to hurt you and that means it goes out of my hands and every, we had a third party guy, a third party prosecutor come and a criminal lawyer come, and they went, the problem is hearing from you like your biggest struggle, this is just, is that it is the most solid evidence, case of domestic violence case we've ever seen. And if you get this over to them or any part of it they will prosecute him. And I felt like, I would never want that. For you. Because I don't even, it's hard for me, I don't even call myself, like, in my head it's hard for me to even accept any sort of victimhood, ever.

JD: Amber, listen, here's-

AH: And I don't want to hurt you.

JD: I understand. I understand. And I don't want to hurt you either. I'm only going to say this. I love you [laughs]. I love you. I've always loved you. And I know that, look, you do whatever you feel you have to do. I'm telling you now it's a mistake to go to court. If you want to go to court, we'll go to court. I would rather take care of it in a different way, I think it would be very good for you, and it would be very good for me. But you know what? Baby-

AH: I've been called a liar.

JD: Baby, you know what?

AH: And I've been called a golddigger.

JD: Baby. Baby. Amber, I didn't call you those things. I didn't call you those things.

AH: It's all from your side and you don't believe me then why are we talking? It's so pointless to even like talk like we don't trust or love or respect each other at all if you don't believe what I'm saying. And you know it and I know you.

JD: You-

AH: I respect you too much, to pretend for a second, that you don't know me back. And you know it.

JD: Okay, and do you remember me fifteen minutes ago saying that, 'let me make a call, let me get on this'?

AH: Yeah.

JD: And I'll try get back in touch with you. Okay?

AH: Yeah.

JD: So, let's not jump. Let's not jump on me, okay?

AH: I'm not trying to jump on you. I'm sorry.

JD: I'm gonna try and get through and see what the fuck is going on, see what the fuck has been happening. And I will get back to you. I'll call your mom. And-and-and- you know, I'll hope-

AH: I didn't want it to go to that. I didn't want it. I didn't want any of this. I don't want it to be-

JD: It's been going on for too long, Amber and we've just got to stop this. It's got to stop it.

AH: I don't know how to get my reputation back.

JD: We write a letter together. Saying that we are going to take this out of the public eye. Saying that we are going to try and work this out on our own. Saying that the media has created such a f**king hateful storm that it's sickening. That we love each other. And that we want to make sure each other's OK. Have we had fights in the past, have we had this or whatever, f**k it, whatever, they already know all that s**t, it don't matter. Here's the deal.

AH: Oh, it matters. I have been, I have been, you have no idea, every ounce of my credibility has been taken from. And done so in a dishonest way. You know.

JD: Amber, the abuse, the abuse thing is, is we've got to deal with that, yeah. We've got to deal with that Amber.

AH: We don't have any way of, my credit, it's my credibility. You know-

JD: Then why did you put that out there?

AH: I did not. You forced me, your team, forced me to by going on the offense.

JD: I didn't force you to-!

AH: You did. I promise. Look up the timelines to these things and everything is- forget it. Forget it, you don't believe what I say, you don't believe what I say, but I did not, I did not choose this. Every step on the way has been an offense.

JD: I did not put this anywhere. I didn't- let me talk to fucking Dean.

AH: I did not call the cops! I think-

JD: IO called the cops. You told IO to call the cops.

AH: I did not- I did not call the cops and I did not give them any statement when they came, I've been trying to protect you. I-

JD: You told IO to call the cops.

AH: When, while it was happening?

JD: Yeah.

AH: Well I'm sorry. I'm sorry because the last time it got crazy between us I really did think I was gonna lose my life. And I thought you would do it on accident. And I told you that. I said oh my god, I thought the first time.

JD: Amber, I lost a f**king finger man, c'mon. I had a f**king, I had a f**king mineral can, a jar, a can of mineral spirits thrown at my nose.

AH: You can please tell people that it was a fair fight, and see what the jury and judge thinks. [mocking] Tell the world Johnny, tell them Johnny Depp, I Johnny Depp, a man, I'm a victim too of female domestic violence.

JD: Yes.

AH: And I, you know, it's a fair fight. And see how many people believe or side with you.

JD: It doesn't matter, fair fight my a**.

AH: That's exactly. Because your big, you're bigger and you're stronger. And so when I say that I thought that you could kill me, that doesn't mean you counter with you also lost your own finger. I, I'm not trying to attack you here, I'm just trying to point out the fact of why I said call 911. Because I was, you had your hands on me after you threw a phone at my face. And it's got crazy in the past, and I truly thought I need to stop this madness before I get hurt.

JD: [exasperated] Oh my god.

AH: And I never think about myself that way. I never defend myself that way. I never see myself as a victim.

JD: [exasperated] Alright.

AH: It's your fault, you know?

JD: Alright, yeah.

AH: And I, I, when they came, I did not cooperate with them and it has been used against me – not by the media, by your side. Who said-

JD: What do you mean where's the media- don't dole out the media, why is my side-?

AH: TMZ is in your pocket and you don't even know it? Oh, I mean it's – I was at the court house while TMZ was posting things. At the court house while they were posting things about the cops never coming, right? So, we provide proof. 'Oh, just one set of police officers' and then they retract their story but they don't actually retract it like an objective media source would. No, what do they do they? They just come up with a new lie, it was just one pair of cops and she said it was two. And I said no, here's the proof. We subpoenaed the building for actual security records to prove that was wrong. Okay, what do they do, they come out with a new lie, a different lie. Okay, this is, this it. I mean, every step of the way I've had this tape, it's been because, that news source, in Morty's pocket. Like, that's like Laura's source.

JD: Okay, listen.

AH: Every step of the way.

JD: Alright, listen here's the-

AH: [unintelligible]

JD: Alright, fine, you believe what you wanna believe. I'm gonna call these people, I'm gonna take care of this, see what the fuck is going on. I'll get back to you. Otherwise, listen, as far as I can tell right now it sounds like you wanna go to court. You wanna fuck this up real bad.

AH: I don't! I just wanna clear my name! I've been telling all lawyers this from the beginning and your lawyers knew this.

JD: You cannot clear up your name now.

AH: Don't let them lie to you. Don't let them lie to you. I've only said this from the very beginning. I only have my integrity and the unfortunate thing is that-

JD: What about mine?

AH: -step further

JD: What about mine?

AH: They keep- that's what I keep- I'm trying to say you. Literally, in words, I'm out of my mouth that's what I'm trying to say to you. Every step of the way, I've said to them thing is they are hurting Johnny by this because every time they call me a liar or this is not true or Stephen's text messages never actually happened, or- or your security guards, which by the way was follow up to your security guard thing that they never saw it these things happening, these security guards, who by the way have said to me multiple times that I'm gonna get killed. And one, on accident, I had the phone out fucking recording on the table- when you know we're doing the thing where we record it and we finished, walk away or whatever and I catch Jerry Judge on- making calls- after that-which I didn't even know I had done, I had left me phone out on the table in the same room where we were having a fight and left the room and Jerry was on the phone- I mean, it's- him saying that he didn't acknowledge any physical violence. You have no idea how bad this is going to be for every single person that has come on the record. Now, there's record of now Jerry and Shaun saying that, both of which I can prove, heard. I mean- acknowledge.

JD: [sarcastic] There's also Travis coming to get me, there's Travis having to come up and f**king pull me away from you.

AH: Yeah, put that's you saying that to Travis, that's different from Jerry Judge saying to- going on record saying that he has never witnessed any violence and then me having a phone call – a phone conversation recorded of him, saying exactly that. Not to mention, multiple times, would- they would have to do this under oath obviously, they are gonna have to say they didn't see it and hurt me and other people who have heard them.

JD: You're going to have to do this under oath too, you know?

AH: I will because the unfortunate part is I can talk about all of this.

JD: Do you believe all this Amber? Do you believe all this?

AH: Yes, the f**k, yes, yes.

JD: You believe I'm an abuser?

AH Yes.

JD: You believe I'm an abuser?

AH: In May, In December, in, in April

JD: Do you believe you're an abuser?

AH: No.

JD: Do you believe you abused me physically?

AH: Do I physically believe, I mean do I believe I physically abused you?

JD: Yes?

AH: Do you know I'm a 115, well not anymore, but I was a 115lb almost 115lb woman and your saying I have the capacity to abuse-

JD: That's not the question. That's not the question.

AH: Have I ever been able to knock you off of your feet? Or knock you off balance?

JD: You started. You started these things.

AH: [mocking] You're going to get up on the stand, Johnny, and say, 'she started it'? Really? I have never been able to overpower you that's the difference between me and you.

JD: Why did you try?

AH: And that's a difference, that's a whole world, and there's a jury and there's a judge will see that there's a very big difference between me and you. And all the people who have come out and lied on your behalf that I can- I can prove they fucking lied, whether be by text messages, they can be authenticated by third party forensic- uh-uh electronic forensic research person or if it's audio or if it's photos. They are- there is so much evidence, it blows- there is no reason, there is no reason that all this had to come out but every step of the way, you're- I mean, I'm not thinking about security not doing their jobs or doing their jobs and they came out with it. That was proactive- that was proactive step. I had to respond.

JD: You cannot automatically, you cannot think that it's just my side. You are f**king killing me. Your f**king people are trying to kill me. You've turned me into a, my boy has to go to school, my boy goes to school and has kids go 'so your f**king dad's a wifebeater'? You don't think about that Amber.

AH: You don't think also my family, and all the death threats? Me and every single person in my immediate circle of friends and family is getting also matters? And you don't think I, you don't think I?

JD: Death threats?!!

AH: Your people put this out. Why, why, why, why did your security go on the record and lie? Why, that's a proactive measure. Why did your divorce attorney get to file for divorce period? At all? Second, why did she have to go and leak to TMZ? Why if you wanted it private, is TMZ being fed information literally by Laura Wasser and Marty Singer every step of the way? My, my my my arrest records. Who put that in the media? The rumors that I was a stripper? Or, of course I can expect that. I've known every step of the way, every single step of the way everything you give 'em.

JD: I give 'em? I give 'em? That's it. I give 'em? I'll see you in court. No. I'll f**king see you in court. I will f**king see you in court. I never f**king said that. I never told anyone that. You f**king trusted me with that and I never f**king told anyone that. And you know what, Amber?

AH: Thank you.

JD: This is not, no, this is me. This is me saying I tried. And thank you. And I will see you in f**king court. You don't want to make f**king nice nice? I'm trying. I'm trying. But you know what? You, I loved you for so many f**king years but you know what? You didn't exist. You don't exist. You're not there. You're not there. You are a f**king made up thing in my head. And I can't believe you are doing this to me.

AH: Stop, stop, stop. There's no need to be cruel on top of it.

JD: You have been nothing but cruel and I'm going to court with you.

AH: I'm just here defending myself and it makes you so angry.

JD: You have not let up, you keep blaming me. What you just said-

AH: I'm defending myself! I'm defending myself!

JD: What you just said- What you just said to me-

AH: I'm defending myself! I'm defending myself!

JD: You're defending yourself against me about something I didn't even fucking do and I'm not gonna fight with you because that shit will last forever.

AH: No, I didn't, I said I could accept it next. [not entirely sure, my best guess] I'm just defending myself.

JD: Excuse me.

AH: I'm just defending myself.

JD: Excuse me

AH: I'm defending myself on the phone right now and you are attacking me!

JD: Excuse me, I'll be right back.

AH: Then you be cruel on top of it!

JD: Can you give me one minute, please? May I have one minute, please? I'll be right back.
